

ORDINANCE NO. 12-1-1, 2000

AN ORDINANCE RELATING TO THE VACATION OF THE ALLEY IN  
BLOCK 72 IN THE TOWN OF MOFFAT, COLORADO

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF  
MOFFAT, COLORADO:

SECTION 1. The Board of Trustees, in adopting this ordinance, finds, determines and declares that the alley running north and south through Block 72 in the Town of Moffat is a public road within the Town of Moffat; that no land adjoining said alley is left, by reason of this vacation, without an established public road connecting said land with another established public road; that such alley is not used or held for any public utilities and is not used or held for any governmental purposes of the Town of Moffat; and that for the above-stated reason and other reasons, the proposed vacation is in the best interest of the health, safety, morals, convenience, order, prosperity and welfare of the citizens of the Town of Moffat.

SECTION 2. That the alley in Block 72 in the Town of Moffat be and the same is hereby vacated.
