

ORDINANCE NO. 2023-03

AN ORDINANCE AMENDING ORDINANCE 2023-01 IN ORDER TO RESTATE THE DESIGNATION OF THE LOCAL LICENSING AUTHORITY FOR THE TOWN OF MOFFAT WITH RESPECT TO REGULATED MARIJUANA BUSINESSES REGULATED MARIJUANA IN THE TOWN OF MOFFAT, COLORADO

WHEREAS, the Board of Trustees of the Town of Moffat, Colorado, has determined it necessary to amend its current Ordinance 2023-01 (AN ORDINANCE AMENDING ORDINANCE 2021-05 AND THE FRAMEWORK FOR REGULATED MARIJUANA IN THE TOWN OF MOFFAT) in order to restate the designation of the Local Licensing Authority for the Town of Moffat.

NOW THEREFORE, be it ordained by the Board of Trustees of the Town of Moffat, that Ordinance 2023-01, be amended to read as follows:

Section 2 – Local Licensing Authority.

(A) The Town Manager is hereby designated as the Local Licensing Authority for the Town of Moffat with respect to Regulated Marijuana Businesses.

THE TOWN BOARD OF TRUSTEES FINDS THAT THIS ORDINANCE IS NECESSARY TO THE IMMEDIATE PRESERVATION OF PUBLIC PEACE, HEALTH, AND SAFETY, AND SHALL TAKE EFFECT AND BE ENFORCED IMMEDIATELY UPON THE FINAL PASSAGE OF THIS ORDINANCE
