ORDINANCE NO. 2023-06

ORDINANCE OF THE TOWN OF MOFFAT, COLORADO, ENACTING A PLANNING AND ZONING COMMISSION FOR THE TOWN OF MOFFAT, COLORADO

WHEREAS, the Board of Trustees has seen growth and development within the Town of Moffat, and

WHEREAS, the Board of Trustees desires to plan for the orderly, desirable growth and development with the Town of Moffat. Planning for growth is generally part of a Planning and Zoning Commission, and

WHEREAS, the Board of Trustees desires to reestablish and confirm a planning and zoning commission, and

WHEREAS, pursuant to C.R.S. § 31-23-202 the Board of Trustees is authorized to create a planning commission with the powers and duties set forth in part 2 of the stated Statute, and

WHEREAS, the Board of Trustees believes that a Planning and Zoning Commission has been previously established, however it is not currently active and lacking records of appointment of members, and

WHEREAS, pursuant to ~~C.R.S. §~~ C.R.S. § 31-23-306 the Board of Trustees is authorized to create a zoning commission with the powers and duties set forth in part 3 of the stated Statute;


NOW THEREFORE, Be it hereby ordained by the Board of Trustees of the Town of Moffat, Colorado, that the personnel of the Planning and Zoning Commission shall consist of five members as follows: the mayor and a member of the governing body as ex officio members and three persons appointed by the mayor. All members of the Commission shall be bona fide residents of The Town of Moffat. The personnel of the Commission shall also follow all requirements and restrictions of C.R.S. § 31-23-203.

The Commission shall be governed by and comply with all articles of C.R.S. § 31-23-201 et sec.

The Town Clerk is hereby instructed to record this Ordinance in the office of the Saguache County Clerk and Recorder, and according to C.R.S. 43-1-202.7, after such Ordinance is signed. The Town Clerk is also directed to publish this Ordinance as directed in Resolution 2023-01.


FIRST READ and ADOPTED on this 28 day of March, 2023. This Ordinance will take effect and be in force 30 days after publication.
