## **ORDINANCE 2023-07**

AN ORDINANCE AMENDING ORDINANCE NO. 2022-01 (AN ORDINANCE OF THE TOWN OF MOFFAT, COLORADO, REPEALING ORDINANCE NO. 2016-01 (AN ORDINANCE ESTABLISHING COMPENSATION FOR THE MAYOR OF THE TOWN OF MOFFAT, COLORADO) AND FURTHER ESTABLISHES COMPENSATION FOR THE MAYOR AND THE BOARD OF TRUSTEES OF THE TOWN OF MOFFAT, COLORADO) TO MORE CLEARLY STATE THE REQUIREMENTS FOR COMPENSATION OF ELECTED OFFICIALS

WHEREAS, Ordinance 2022-01 established compensation for its Town Officers; and

WHEREAS, the Town of Moffat has become aware of the need to update the requirements for compensation of the Mayor and the Board of Trustees.

**NOW THEREFORE**, be it ordained by the Board of Trustees of the Town of Moffat, Colorado, that the above referenced Ordinance be amended as follows:

That the compensation for the Mayor and the Board of Trustees of the Town of Moffat, a statutory town, shall be set at \$420.00 per month for the duration of the term of office.

## AND

If the Mayor or a Trustee misses the any of the monthly meetings, as set forth in State Statute, due to unexcused absences as determined by the Board of Trustees, the compensation will not be paid to the Mayor or said Trustee for that month.

## AND

If the Mayor or a Trustee abuses their role as an elected official by misconduct or malfeasance (as those terms are used in Article XIII, Section 3 of the Colorado Constitution), or by threats, acts of violence, or other criminal means, the compensation will not be paid to said Mayor or Trustee for that month. Charges for removal shall be issued and a public hearing will be held in accordance with C.R.S. 31-4-307.

## AND

Compensation of the Mayor and the Board of Trustees shall commence at the beginning of their term of office with the Town of Moffat.

THE TOWN BOARD OF TRUSTEES FINDS THAT THIS ORDINANCE IS NECESSARY TO THE IMMEDIATE PRESERVATION OF PUBLIC PEACE, HEALTH, AND SAFETY, AND SHALL TAKE EFFECT AND BE ENFORCED IMMEDIATELY UPON THE FINAL PASSAGE OF THIS ORDINANCE
