

**TOWN OF MOFFAT, COLORADO  
ORDINANCE NO. 2019-14**

**AN ORDINANCE REGULATING HEMP CULTIVATIONS  
IN THE TOWN OF MOFFAT**

**WHEREAS**, in an effort to reduce any cross-pollination between hemp and marijuana being grown and produced in the Town of Moffat, the Board of Trustees finds the need to eliminate the use of male cannabis seeds or plants within the Town limits of Moffat, and eliminate the use of any property in the subdivision known as CO Area 420 for the cultivation of hemp; and

**WHEREAS**, due to high winds in the San Luis Valley, this will not completely eliminate the possibility of cross-pollination, but will assist in an effort to reduce cross-contamination, which can ruin cannabis crops; and

**WHEREAS**, any business shall provide certification or proof of seed or hemp gender upon Town's request; and

**WHEREAS**, "Marijuana" describes a Cannabis Sativa plant that has been bred for its potent glands, known as trichomes. Trichomes contain high amounts of tetrahydrocannabinol (THC). "Hemp" describes a Cannabis Sativa plant that contains trace amounts of THC no greater than 0.3%; and

**WHEREAS**, per Colorado State Law, all hemp must contain 0.3% or less of THC, or it will otherwise be considered marijuana.

**WHEREAS**, The Town of Moffat Board of Trustees does hereby find and determine that it is in the best interest of the Town to require that any hemp grown and produced in the Town of Moffat derive from feminized seed and plants only, and contain less than 0.3% tetrahydrocannabinol.


**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE  
TOWN OF MOFFAT, COLORADO:**

That the Town of Moffat requires all cannabis plants derive from feminized seeds and plants, and that per Colorado State Statute all hemp shall contain 0.3% or less of tetrahydrocannabinol.




