## TOWN OF MOFFAT, COLORADO RESOLUTION NO. 2018-21- 2018 BUDGET AMENDMENT

A RESOLUTION MAKING SUPPLEMENTAL APPROPRIATIONS AND AUTHORIZING EXPENDITURES IN EXCESS OF AMOUNTS BUDGETED FOR THE TOWN OF MOFFAT IN RESOLUTION 2017-6 AND RESOLUTION 2017-5 AND KNOWN AS THE 2018 BUDGET ADMENDMENT.

WHEREAS, the Town of Moffat, Colorado adopted Resolution 2018-6 Hiring a fulltime clerk and has sufficient fund balance for the expenditure due to increases in tax revenue; and
