Did you know Coloradans use an estimated 4.6 million single-use plastic bags every day? Plastic bags are produced from non-renewable resources and are very difficult to recycle. A new statewide law in Colorado, the "Plastic Pollution Reduction Act," will impose a 10-cent fee for each single-use bag on Jan. 1, 2023. You can avoid the fee by bringing your own reusable bags to the store.

Colorado Law - Plastic Pollution Reduction Act

Jan. 1, 2023: a <u>new Colorado law</u> will require businesses with more than three locations in Colorado to impose a 10-cent fee on single-use plastic and paper bags

Jan. 1, 2024: Colorado law will ban single-use plastic bags at most stores and expanded polystyrene foam takeout containers (more commonly known as Styrofoam) at restaurants

Single-Use Bag Fee FAQ's

Any of the following types of businesses which operate in multiple States or has more than 3 locations in Colorado:

- Grocery stores and supermarkets
- Convenience stores
- Liquor stores
- ❖ Retailers
- Other stores that provide plastic bags Including ant self-checkout and delivery services

Are there any exceptions to the bag fee?

- Stores operating only in Colorado, with three or fewer locations
- Restaurants

What is a single-use bag?

❖ A single-use bag means a bag that is not reusable and is destined for our local landfill or recycling process. The bag fee is only on single-use bags distributed to customers at the point of sale, and the bad ban taking effect in 2024 is only on single-use plastic bags.

Single-use bag does not include

- ❖ Bags used by consumers inside stores to
 - Packaged bulk items, such as fruit, vegetables, nuts, grains, candy, or small hardware items
 - Contain or wrap frozen foods, meat, or fish
 - Contain or wrap flowers, potted plants, or other items where dampness may be a problem
 - Contain unwrapped prepared foods or bakery goods
- ❖ A non-handled bag used to protect a purchased item from damaging or contaminating other purchased items when placed in a recyclable paper bag or reusable bag
- ❖ Bags provided by pharmacists to contain prescription drugs
- Newspaper bags, door-hanger bags, laundry-dry cleaning bags. Or bags sold in packages containing multiple bags for use such as food storage, garbage, pet waste, or yard waste bags

When does the single-use bag fee take effect?

❖ The Statewide single-use bag fee takes effect in January 1, 2023.

How much is the bag fee?

❖ The fee is ten cents (\$0.10) per plastic or paper bag.

What businesses must follow the plastic bag and Styrofoam ban Starting on January 1, 2024?

- ❖ All of the businesses that must follow the single-use bag fee in 2023 must follow the plastic bag ban in 2024.
- Including any self-checkout and delivery services
- * Restaurants and other retail food establishments (for Styrofoam)

How do businesses comply with the bag fee?

❖ Per a <u>Colorado law</u> passed in 2021, stores and retail food establishments, with more than 3 locations in Colorado, will be required to charge customers a \$0.10 fee for each single-use plastic and paper bag used at the point of sale starting on January 1, 2023. Businesses will retain four cents of the fee to cover the

- costs of administration and compliance while six cents are to be remitted to the local government on a quarterly basis.
- For applicable businesses within town limits, the returns will be submitted to the Town of Moffat at least on a quarterly basis. A monthly option is also provided for businesses who wish to submit on a more frequent basis, such as for businesses that file monthly sales tax returns.
