3. APPROVAL OF AGENDA

a. Approval of Agenda

Mr. Horsley has been accused of not reporting crimes when they occur. He invites people who are accusing him of not reporting when crimes occur, to notify the mayor because he would obviously need to be let go.

Ali Lopez report that the trash at the park is overflowing.

Patty Reigel wants the corner of town hall fixed and put in the budget and the state historical fund needs to be notified.

Ms. Myers says she has reached out to the state historical fund and the town is on a list.

Ms. Justice asks if the town has a code of conduct regarding trustees speaking on matters discussed in executive session? Mr. Studinski says there is a resolution that was adopted in 2024 but it does not address confidentiality. Confidentiality is covered in general by state statute. Ms. Justice would like to see that language added to the resolution is the resolution is ever adopted, that trustees should not share information that is communicated in executive session.

Peggy Gotfried speaks about attorneys and moving water from Potch LLC's well to the towns water and it looks in order. She says there were things the board was not happy about from earlier but this order from this week looks to be right. It gives the town 10 years if there were any entry in to wells around Moffat that were... the rest is inaudible.

Trustee Myers directs the clerk the she wishes to clarify the above public comment (Peggy Gotfried) via court document with this excerpt. "The Court shall retain jurisdiction for reconsideration of the question of injury to the vested rights of others due to the change of water rights for a period of ten years commencing on the date of the decree entered in this matter." This document is included in the meeting packet. It was included post meeting.

Ms. Reigel asks if Mr. Studinski has done the due diligence to become the mayor?

Mr. Studinski chooses not to answer the question.

6. NEW BUSINESS

a. Discuss and take action on a waiver of confidentiality for the 7/2/2024 Executive Session audio.

The board discusses the redacted audio and a waiver of the confidentiality of that audio.

Mr. Reichwald makes a motion to waive of confidentiality for the audio file in question. Mr. Berger recuses. Ms. Myers abstains. Mr. Reichwald, Mr. Catts, and Ms. Kelber vote yes. Motion passes 3-0.

b. Discuss and take action to hire an independent chair for the Berger hearing.

Mr. Studinski states that because he brought the charges against Trustee Berger, he feels it is not appropriate that he chair the public hearing for Mr. Berger. The board discusses placing an independent chairperson for the Trustee Berger Hearing on August 20th 2024.
