Official Call for Town of Moffat Trustee/Mayor Candidates

The Town of Moffat is inviting interested residents to apply to run for election for **Town Trustees and Town Mayor** at the upcoming municipal election on **Tuesday, April 7, 2026**.

What You Should Know:

- **Board Structure:** The Town Board is comprised of a mayor and six trustees.
- **All Board positions are up for election on April 7, 2026.**
- **Terms & Duties:** The candidate who is elected mayor will serve a 4-year term. As to trustees, the three candidates who receive the highest number of votes will serve 4-year terms. The three candidates with the next highest number of votes received will serve 2-year terms. Beginning with the 2028 election all elected officials will serve 4-year terms.
- The Board of Trustees is responsible for governing the Town by establishing policies, setting goals, adopting laws and ordinances, managing town finances and property, and approving the annual budget. They collectively act in the public's best interest, holding a fiduciary responsibility to manage Town affairs with care and ensuring compliance with local, state, and federal laws. The mayor or, in his or her absence the mayor pro tem, shall preside at all meetings of the Board of Trustees.

Eligibility Requirements:¹

- Registered voter.
- Resident of the Town of Moffat for at least 12 months prior to the election.

How to Apply:

1. Request a **Candidate Packet** (including Nomination Petition, Acceptance of Nomination letter, and Circulator Affidavit) from the Town of Moffat's Clerk's Office beginning January 6th 2026.²
2. Collect at least **10 signatures** from registered Moffat voters.³
3. Submit the completed forms to the Town Clerk by January 26th 2026.⁴

Key Dates:

- Tuesday, January 6th, 2026 - Candidate Packets available at Town Hall
- Monday, January 26th, 2026 – Candidate Packets must be completed and returned to the Clerk by 3:00pm
- Tuesday, February 3rd, 2026 – Last day to correct any discrepancies with nomination petition⁵
- Tuesday, April 7th, 2026 – Election Day.

Important Information:

Each registered elector can only sign as many petitions as there are offices to be filled. Thus, each registered elector may only sign as described below:

Mayor: One (1) nomination petition

Trustee: Six (6) nomination petitions

In the event that more signatures are received for a certain position than authorized, the clerk will use the earliest date of signature to determine which signature is valid. If the dates are the same, or the clerk cannot determine which signature is valid, all signatures will be rejected.⁶
