ORDINANCE NO. 2024-06

AN ORDINANCE OF THE TOWN OF MOFFAT, COLORADO TO ENACT THE APPROVED BALLOT MEASURE FOR THE TOWN OF MOFFAT TO PUBLISH ORDINANCES BY TITLE ONLY RATHER THAN PUBLISHING ORDINANCES IN FULL PURSUANT TO C.R.S. § 31-16-105; PROVIDING FOR A REPEAL AND SAVINGS A CLAUSE; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of Trustees ("Board") for the Town of Moffat, Colorado ("Town") asked the qualified voters of the Town to permit the Town of Moffat to Publish approved ordinances by title only; and

WHEREAS, the voters approved the ballot measure on November 5, 2024, and the Board believes that this will enable the town to decrease expenses by minimizing publication costs, while still promoting full transparency to citizens.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES FOR THE TOWN OF MOFFAT, COLORADO

SECTION 1. The foregoing premises and findings are found to be true and correct and are incorporated into the body of this ordinance as if copied in their entirety.

SECTION 2. The Town of Moffat shall publish ordinances in the newspaper by title only pursuant to the election of November 5, 2024, and C.R.S. § 31-16-105.

SECTION 3. Any and all existing Ordinances or parts of Ordinances of the Town of Moffat inconsistent with the provisions of this Ordinance are hereby repealed. If any section, subsection, sentence, clause, or phrase of this Ordinance is, for any reason, held to be invalid or unconstitutional, such decision shall not affect the validity or constitutionality of the remaining portions of this Ordinance.

SECTION 4. This Ordinance shall become effective from and after its passage and approval and thirty (30) days after publication as may be required by law. The Clerk is directed to make said publication.
