

**RESOLUTION 2024-15 (Repealing Resolution 2024-9)  
TOWN OF MOFFAT, COLORADO**

**A RESOLUTION CANCELING THE MUNICIPAL ELECTION DUE TO NO  
CANDIDATES SEEKING ELECTION**

**WHEREAS**, it appears to the Board of Trustees of the Town of Moffat, Colorado, that there are no more candidates for the Board of Trustees of said Town than there are vacant seats to be filled; and

**WHEREAS**, pursuant to law, an election for these vacant seats will be unnecessary if no write-in candidates file an affidavit of intent prior to nineteen days before the day of the election.

**WHEREAS**, it appears to the Board of Trustees that 2024-9 Needs to be corrected.

**NOW, THEREFORE BE IT RESOLVED**, by the Board of Trustees of the Town of Moffat Colorado:

A. Resolution 2024-9 is hereby repealed.

B. That, provided no affidavit of intent is timely filed by an eligible write-in candidate, candidates that are currently on the board, and are not term limited, are hereby declared elected to the Board of Trustees for the following terms and positions at the April regular Town Trustee meeting:


