

**RESOLUTION NO. 2024-18**

**A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF MOFFAT, COLORADO, ADOPTING AN AMENDED AND RESTATED FEE SCHEDULE FOR THE TOWN OF MOFFAT; REPEALING RESOLUTION 2022-11, RESOLUTION NO. 2022-04 AND RESOLUTION NO. 2016-08; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the Board of Trustees ("Board") for the Town of Moffat, Colorado ("Town") finds it necessary to amend the Town's fee schedule from time to time to account for the current costs associated with the processing, issuance, renewal and enforcement of various permits and licenses issued by the Town; and

**WHEREAS**, the last update to the Town's fee schedule occurred in 2022 with the adoption of Town Resolution 2022-11; and

**WHEREAS**, the Board finds that it is currently necessary to amend and restate the Town's fee schedule to offset the current costs incurred by the Town to administer the Town's various permits and licenses; and

**WHEREAS**, the Board further finds that adoption of the amended fee schedule attached to this resolution is necessary to preserve the health, safety and welfare of the Town's residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF MOFFAT, COLORADO THAT:**

**SECTION 1.** The above and foregoing premises are true and correct and are incorporated herein and made a part hereof for all purposes.


