A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF MOFFAT, COLORADO, ADOPTING AN AMENDED AND RESTATED FEE SCHEDULE FOR THE TOWN OF MOFFAT; REPEALING RESOLUTION 2022-04; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Board of Trustees ("Board") for the Town of Moffat, Colorado ("Town") finds it necessary to amend the Town's fee schedule from time to time to account for the current costs associated with the processing, issuance, renewal and enforcement of various permits and licenses issued by the Town; and

WHEREAS, the last update to the Town's fee schedule occurred in 2024 with the adoption of Town Resolution 2024-18; and

WHEREAS, the Board finds that it is currently necessary to amend and restate the Town's fee schedule to offset the current costs incurred by the Town to administer the Town's various permits and licenses; and to provide a fee schedule that includes the citizen approved TABOR ballot measure providing for a \$2000 Annual Occupational Tax for all Retail (Recreational) Marijuana Cultivation Renewals implemented by Ordinance 2024-08; and

WHEREAS, the Board further finds that adoption of the amended fee schedule attached to this resolution is necessary to preserve the health, safety and welfare of the Town's residents.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF MOFFAT, COLORADO THAT:

SECTION 1. The above and foregoing premises are true and correct and are incorporated herein and made a part hereof for all purposes.

SECTION 2. The Board hereby adopts the amended and restated fee schedule attached hereto as Exhibit A, which shall be effective on 1/15, 2025.

SECTION 3. Resolution 2024-18 is hereby repealed and replaced in its entirety upon adoption of this resolution.

SECTION 4. This Resolution shall take effect immediately from and after its date of adoption.
